### **Treasurer's Report**

- Treasurer Michelle Clark distributed Treasurer's Report, General Unrestricted Fund Detail and Maturing CD List to members
- Rosemary Hillman asked about making a presentation to the membership re: our gift to HSF
- Chris Foss asked if a "big check" could be used, wondering if Pat Henson could get one like the Zoo Foundation uses
- Report was filed for audit

# **Special presentation:**

- Lorna Truck presented on Scholarship money, earnings request, tracking requests and to make 2 endowed scholarships.
- Liz Teufel moved that the Finance Committee move funds to make 2 endowed scholarships whole as recommended by the external audit
  - 1. Move \$5,677.00 from the General Unrestricted Account to the Endowed Memorial Account for the Schwartz Scholarship. (The original bequest language named the gift as a percentage (40% of the estate rather than a specified amount).
  - 2. Move the entire Znerold savings account (about \$3988) and an additional \$9030 from the General Unrestricted Account to the Endowed Memorial Account to replace a total of \$13,018 in the O'Braza Scholarship which was used to restore the stained glass skylight in the house stairway.

- Rosemary Hillman seconded the motion
- Motion passed

Discussion followed, Lorna Truck was asked about the Finance Committee's choices of investments, she replied the last approval of policy of investments was in March 2010. Pat Henson commented on Zoo Foundation not investing in what is considered not socially responsible, i.e. tobacco, guns, etc.

Lorna Truck responded this is being taken into consideration.

Sheila Sapienza brought up the idea that "socially responsible" is a personal thing Finance Committee makes investment decisions based on advice of the DMWC advisor, who is a volunteer, not hired.

Michelle Clark asked how we would know

Pat Henson responded the investment advisor could provide the proper language Lorna Truck said we may need to hire an advisor. Tammy Schroeder is the current advisor, she is a member and a volunteer

Rosemary Hillman feels comfortable with Tammy but the club may want to look to hire Chris Foss asked if there is a conflict of interest when the advisor is also a club member Jean Shires commented Tammy does not tell us what to buy

- Joanne McCracken-Young moved the DMWC Board expresses their profound appreciation to the Finance Committee for all their work.

- Motion carried

Lorna Truck asked for feedback to the Finance committee, Chris Foss asked if Finance committee can recommend what we should do, Pat Henson said we should send recommendations, Liz Teufel commented Jayne Sullivan has said policies should be approved every year for review.
